H.O.M.E. Initiative Expands Housing Access and Affordability in Philadelphia

Mayor Cherelle L. Parker recently announced the Housing Opportunities Made Easy (H.O.M.E.) Initiative. This plan is a key step in her goal to create and preserve 30,000 housing units.

H.O.M.E. will expand affordable housing, streamline development processes, and support low-wage workers, veterans, municipal employees, and other residents in need.

To lead this effort, Mayor Parker appointed Angela Brooks as the City's first Chief Housing & Urban Development Officer. Brooks brings decades of experience in housing policy. The initiative is expected to create 41,500 jobs in construction and trades, strengthening Philadelphia's workforce and economy.

H.O.M.E. will also establish an Advisory Board of housing experts to guide policy changes and increase housing access.

More details, including funding plans, will be shared in the Mayor's Fiscal Year 2026 Budget Address. Stay tuned!
